# **Uterine Fibroid Embolization (UFE)**

#### 2023 CODING AND REIMBURSEMENT GUIDE

Coverage, coding and payment for medical procedures and devices can be confusing. This guide was developed to assist with Medicare reporting and reimbursement when performing transcatheter peripheral embolization or occlusion procedures. ### Coverage

Medicare carriers may issue local coverage decisions (LCDs) listing criteria that must be met prior to coverage. Physicians are urged to review these policies (<a href="http://www.cms.hhs.gov/mcd/search.asp?">http://www.cms.hhs.gov/mcd/search.asp?</a>) and contact their carriers' medical directors (<a href="http://www.cms.hhs.gov/apps/contacts">www.cms.hhs.gov/apps/contacts</a>) or commercial insurers to determine if a procedure is covered.

### Coding

The following Current Procedural Terminology (CPT®) code is a bundled code, which includes all radiological supervision and interpretation; intra- procedural guidance and roadmapping; and imaging to document the completion of the procedure.

#### The CPT®code used to describe uterine fibroid embolization is:

37243

Vascular embolization or occlusion, inclusive of all radiological supervision and interpretation, intraprocedural roadmapping, and imaging guidance necessary to complete the intervention; for tumors, organ ischemia, or infarction

37243 does not include vessel selection and catheter placement(s); ultrasound guidance for vascular access; diagnostic studies (eg, diagnostic angiography or venography); chemotherapy administration (eg, 96420); or injection of a radioisotope (eg, 79445).

Do not report 37243 in conjunction with 75894, 75898 in the same surgical field.

For embolization procedures of the central nervous system or head and neck, see 61624, 61626, 61710.1
